### MOZILLA

#### [COVID-19 Solutions Fund](#)

As part of the COVID-19 Solutions Fund, we will accept applications that are hardware (e.g., an open source ventilator), software (e.g., a platform that connects hospitals with people who have 3D printers who can print parts for that open source ventilator), as well as software that solves secondary effects of COVID-19 (e.g., a browser plugin that combats COVID-related misinformation).

### OPEN ROAD ALLIANCE

#### [Direct COVID-19 Response - Charitable Grant](#)

This grant is for organizations engaging in direct COVID-19 response. We will prioritize organizations and activities that have a clear and direct role in 'flattening the curve' and thus limiting, shortening, or minimizing the economic and social, as well as health effects of the pandemic. Slowing and stopping the spread of COVID19 is directly linked to reducing and limiting the economic and social hardship our communities are experiencing.
